Paperwork needed

1. Proof of notice to board that the position is open and how anyone interested can apply for the position. email to board, with copy sent to Area Director so it can be printed
2. Copy of minutes of the meeting at which the vote was taken.
3. Current budget
4. Regional Commissioner Appointment form.

Timetable: In order to guarantee that the Regional Commissioner will be appointed by the National Board before the expiration of the current Regional Commissioner's term, all paperwork needs to be delivered to the Area Director at least 2 months prior to the expiration date of the current Regional Commissioner. eAYSO access rights for RC will terminate the day after his/her term ends.
